



- Only Early Bird Discount is supported in Online Applicants (Application). To enjoy other types of discount, please visit one of our enrolment centres.
- HKU SPACE Mastercard cardholders who wish to enjoy 10-month interest free instalment scheme (only applicable to courses with tuition fees of HKD 2,000 or above.) must pay their tuition fees in person at any of our HKU SPACE Enrolment Centres.
- Applicants who wish to apply for award-bearing programmes should prepare the required documents for upload (please refer to the Programme's webpage). Submitted documents must be in doc, docx, jpg or pdf format, with each file not exceeding 20MB in size.

To study in Hong Kong, all non-local applicants are required to obtain a student visa issued by the Immigration Department of the HKSAR Government, EXCEPT for those admitted to Hong Kong as dependants, or on a Permit for Proceeding to Hong Kong or Macao (also known as "Oneway Permit"), or under any of the schemes indicated in paragraph (I) below, who do not need prior approval before taking up full-time and part-time studies. Non-local applicants who are issued with a valid employment visa or training visa, or members of the Consular Corps, or foreign domestic helpers, or admitted under any of schemes listed in paragraph (II) below, also do not need prior approval to pursue part-time studies. It is the responsibility of individual applicants to make appropriate visa arrangements. Admission to an HKU SPACE academic programme/course does not guarantee the issue of a student visa. Applicants may wish to note that part-time courses are not considered by the Immigration Department for student visa purposes except for self-financed, part-time locally accredited taught postgraduate programmes awarded within the HKU system through HKU SPACE.
